

Streetwise Lightning Rod Stun Baton Instructions (SWB7000R)



WARNING: When testing or using the stun baton in self-defense, don't touch the Stun Strips that extend down approximately 7.5 inches from the top of the unit. When the Stun Activation Button is pressed, these metal strips conduct electricity. They will shock you if you come into contact with them.

CHARGING

The rechargeable batteries are already installed. Please do not attempt to open the unit, as this will void the warranty. It is recommended charging the unit before it is initially used. Simply plug the charging cord into the bottom of the unit and then plug the opposite end of the charging cord into the wall outlet. The recommended charging time for this unit is 2.5 to 3.5 hours. When charging, the indicator light will turn green. **IMPORTANT: Don't charge for more than 5 hours at a time.** Overcharging can damage the unit and void the warranty. Under normal use the unit will need to be charged for 5 hours every 60 days. If the LED flashlight is used frequently or if the electrical current becomes noticeably weaker, the unit will need to be charged. To keep the batteries functioning properly the unit MUST be charged at least 2.5 hours every 90 days. Failure to do so could damage the unit and will void the warranty.

LED FLASHLIGHT


Make sure the unit is fully charged before first use. When not in use, the Function Switch should be in the bottom position. To use the flashlight, slide the function switch to the up position (make sure it clicks once). *Note: repeating this step will change the flashlight mode.* The modes are Hi. Low, and Strobe.

TESTING THE STUN BATON

Important: be sure to hold only by the handle and do not come in contact with the stun strips on the side of the unit. To activate the stun, turn the Safety Switch to "ON", then slide the Function Switch to the top position (make sure it clicks twice), and make sure you see the Stun Warning Light illuminate red which means the stun mode is activated. Then, press the Stun Activation button to test fire the stun baton. **WARNING:** Don't test fire for more than one second. You will see and hear a charge fire across the top of the unit between the test probes.

USING THE STUN BATON IN SELF DEFENSE

- With the Function Switch in the top position and the Safety Switch in the "ON" position, touch your assailant's body with the contact probes and press the Stun Activation Button.
- Touching anywhere on the assailant's body will have an effect. However, the maximum effect is achieved in the areas shown to the right:
- When touching the assailant's body, you will not see or hear the electrical charge as you do when the unit is test fired. You can hold down the trigger for more than 1 second, as this will not damage the unit, as it will when being test fired.
- 4. You do not have to be concerned about the effects of the charge being transferred to you. Even if the assailant touches you while being stunned, you will not feel the effects of the charge.

EFFECTS OF THE UNIT ON AN ASSAILANT

- 1. Touching an assailant for less than 1 second will cause minor muscle contractions and have a repelling effect.
- 2. Touching an assailant for 1 to 2 seconds will cause muscle spasms and a dazed mental state.
- Touching an assailant for 3 to 5 seconds will cause loss of balance and muscle control, total mental confusion, and disorientation. All effects to the assailant are temporary; the stun gun can cause no permanent harm.
 (NOTE: The device should not be used for longer than 5 seconds.)

WARRANTY

The lifetime warranty that covers defects in materials or workmanship, with the following exceptions:

- The warranty does not cover damage resulting from accident, misuse or abuse, lack of reasonable care, water damage or excessive moisture, the affixing of any attachment not provided with the product, loss of parts, or recharging the unit in any manner not in accordance with the included instructions.
- The warranty will be voided if the unit has been opened or tampered with in any way (unless by an authorized dealer) or if any unauthorized replacement parts have been used.
- The warranty does not cover corrosion in the battery compartment caused by long-term battery storage.
- The warranty does not cover the charging cord or any other accessories.
- Not following the charging instructions shown above voids the warranty.

NOTICE

Purchaser must check and abide by all local laws governing the possession and use of stun guns. In addition, the stun gun must only be used in a lawful manner for self-defense. **NOTE:** Not to be used on children, persons with heart disease, or any vital part of the human body. Not to be stored or used in environments where it is damp or humid or where there are extremely hot or cold temperatures. Do not use on metal objects.
